**Notes**

Student counts are as reported on the IPEDS Fall Enrollment survey. Faculty counts since Fall 2008 are as reported on the IPEDS Human Resources survey. This includes tenured, tenure-track, lecturers, and other faculty. Faculty counts prior to Fall 2008 are based on data reported to the American Association of University Professors (AAUP). Graduate Teaching Assistants (GTAs) are not included in the faculty counts.

Student and Faculty FTE are calculated using the same formula: the sum of a) the total full-time head count and b) the part-time head count divided by three. IPEDS instructs institutions to exclude students and faculty in stand-alone graduate programs from the student-to-faculty calculation. Therefore, KU's student-to-faculty ratio excludes students and faculty from the schools of Law and Medicine.
